- ❖ **Annual Enrollment Fee:** Single Child \$70.00 Family \$90.00 due beginning of each calendar year.
- ❖ A **deposit of 3 weeks** + enrollment fee is due at the execution of this contract.
- ❖ All Children must attend a minimum of two days.
- ❖ Parents/guardians receiving assistance from the (CCRC, CDSS, etc.) public subsidy program are still responsible for paying any and all amounts not covered by the public subsidy, either if not approved for the whole amount or if payments are discontinued.
- ❖ Hours of Operation 5:30am – 9:00pm. Monday through Sunday.
- ❖ Provider requires a 30-Day notice if services are no longer needed.
- ❖ Payment due every Thursday prior to week of care. Late accounts will be charged a \$40.00 per day.
- ❖ Provider is paid during parental vacation time because the provider is holding a place for child.
- ❖ **Provider's vacation is June 12-16, 2023, December 25-29, 2023. (My Non-Op payment days).**
- ❖ Provider is allowed 7 personal days per year.
- ❖ All meals and snacks provided.
- ❖ Provider offers formula for infants (Iron fortified).

THIS FAMILY CHILD CARE IS COVID COMPLIANT

Thurman-Olive Family Child Care charges at an hourly rate after 25 hours of care per week per Title 5, of the CA Education Code, Division 1, Chapter 19, Subchapter 2.5, Article (3). This hourly rate is in addition to Thurman-Olive Family Child Care full time regular weekly rate. Moreover, additional payment made under the hourly rate for this purpose will not exceed Thurman-Olive Family Child Care full-time weekly rate.

- If your child is absent for any reason, we do not offer refunds.

- Regular fees, even if your child is sick or on vacation must be paid to keep his/her place.
- In the case of a natural disaster, pandemic, or any unforeseen occurrence, Thurman-Olive Family Child Care is still requesting weekly payment from parents regardless if child is present or not (this is applicable for both private and subsidized clients).
- Thurman-Olive FFC will also be closed during 10 non-operational days during the fiscal year. CCRC & parents will be notified a month in advance of closure days.
